

Functions

- It is the responsibility of the anti-ragging committee to ensure a ragging free campus by preventing ragging activities inside the college premises, hostels, canteen, and college buses and in places where students are likely to assemble.
- In any case of intimation of ragging, the anti-ragging committee will meet immediately and a first investigation report (FIR) will be prepared
- The anti-ragging committee will report the incident to the Police
- According to the nature and gravity of the offence, the anti-ragging committee shall recommend the possible actions from the college against those found guilty
- The action is proposed by the anti-ragging committee according to the notification No. 37-3/Legal/AICTE/2009 dated 25-03-2009 of the All India Council for Technical Education
- The anti-ragging committee shall intimate the incident of ragging along with recommended actions to the Principal/College Council immediately after the occurrence of the incident and provide timely updates regarding the status of the case
- The actions taken by the anti-ragging committee will convey the students that ragging is not only to be discouraged but also to be seriously dealt with
- > The anti-ragging committee will supervise the discipline related activities in the college.
