#### ➤ Recounting Conditions:

- 1) Any candidate or his/her **authorized representative** may immediately after completion of the scrutiny and counting request in writing to the **Returning Officer** to re-scrutiny or recount the votes received by all or any of the candidates and the **Returning Officer** shall re-scrutiny or recount the same accordingly.
- 2) The **Returning Officer** may at his own discretion recount the votes either once or more than once when he is not satisfied as to the correctness of any previous counting: Provided however that nothing in these Rules and Regulations shall require on the Returning Officer to recount the same votes more than once.
- 3) The persons present at the time of scrutiny and counting shall be present at the time of recounting.
